В	P/F of all filter, mobil oil and coolant will be the responsibility of contractor at his own risk & cost to change within stipulated time period i-e up to 06 months or 250 running hours whichever comes earlier. PIA will accept actual /Original invoice of the authorized dealer of lubricant, filters and coolant (original receipt must be submitted before changing of above material in the office of Manager Works Office). In case of delay or noncompliance, a penalty of PKR 10,000/- will be deducted from the monthly invoice.			
С	Replacement of batteries if required is the responsibility of contractor only if instructed /directed by Works department. Only approved quality with actual / Original invoice of the authorized dealer along with warranty certificates will be accepted and bill will be proceeded by PIA including all taxes and contractor's profit (only for Batteries).			
D	Repairing of all types of minor works are the responsibility of contractor as per the instructions of concern officer in order to run the operation. The contractor can claim these amounts after the completion of the work. In case of negligence, penalty of Rs.500/- per day will be imposed but not exceeding the 10% of monthly contract value on the contractor or to be deducted from his monthly bills.
