SUB: - **TERM CONTRACT FOR CIVIL, ELECTRIC, HVAC&R AND FURNITURE FOR THE YEAR OF 2022-2024**

- 1) Tenders and contract are meant for Term Contract works required to be done in PIAC premises at Karachi/ Lahore/ Rawalpindi / Peshawar/Sialkot/Faisalabad / Multan & Quetta (Airport and town premises) as per Schedule "A" (MES) and Schedule B (PIAC) for the specified period (Extendable).
- 2) The contractor shall attach pay order of Rs. 15,000/- with his tender as bid money in the name of PIAC. The bid money of unsuccessful bidders will be returned, the bid money of the approved lowest bidders will be treated/retained as security deposit, which is refundable after the successful completion of the term period. It will be however be confiscated if the contractors fail to honor their bids.
- 3) The quotation/tender shall be valid for a period of 90 days from the date of opening of the tender.
- 4) The cost of any single work, for which formal work order will be issued, based on the rates of approved tenders, will not exceed Rs. 500,000/=.
- 5) For restricted areas, as indicated on the schedule the contractor will have to arrange entry passes for his personnel, vehicles and machineries. These passes shall be valid as per procedure laid down by the concerned agencies. All expenses in this respect will be borne by Contractor.
- 6) PIAC is not liable to issue any stores, material of construction machinery required for the completion of job/work.
- 7) Contractor must possess a Van or a suitable carrier for transportation of material. The vehicle must be registered in the name of the firm or proprietor/partner of the firm. A copy of registration be attached without which tender is liable for rejection, or having vehicle rental agreement for complete tenure.
- 8) The contractor must have a telephone/Mobile phone at his office/residence in the name of the firm or owner and documentary proof must be attached, without which tender is liable for rejection. If found no telephone at his residence or office at any later stage then term contract will be liable to termination.
- 9) The Contractor must be registered with PIAC and proof of the current registration must be attached with the tender.



- 10) PIAC reserves the right to get any work executed from standby contractor/other area T.C contractor in case PIAC is satisfied that area contractor is over loaded or is not executing his job effectively. This final decision rests with Manager Concern.
- 11) The contractor should have adequate Nos. of tradesmen like Plumber, Carpenters, Masons and Labors etc as per site requirement. All these should be well experienced. If found otherwise at any stage the contractor has to replace him/them within 24 hours on the instruction of concerned Manager.
- 12) In case the contractor is delaying the job and not executing as per specification and with due diligence, PIA reserves the right to get this job executed through other area T.C contractor or standby at the risk and cost of concerned area contractor. In all such cases PIA's decision will be final and binding for the contractor. Such cost will be met from the security money and outstanding bills of the contractor for other works.
- 13) The contractor shall have to adopt existing safety measures and also those enforced by PIAC – HSE from time to time so as to ensure no disruption of operation or damage to PIA property / equipment especially in the restricted areas.
- 14) Standard Terms & Conditions for execution of PIAC works shall also apply in addition to these terms & Conditions. This may further include different mandatory amendments enforced from time to time by PIA Management.
- 15) This is the sole responsibility of contractor to drop the tender in the tender box placed in the account's office, works division. Karachi by **1500** hours on **7-3-2022**
- 16) Tender will be opened on **7-3-2022** at **1530** hours in the Office of General Manager Facilities Management in the presence of Contractors; who wish to be present.
- 17) Each and every page must be signed with seal of the firm. Non-compliance will make the tender liable to rejection.
- 18) This subject contract will be for about a period of 12 months, which can be extended for a further period on mutually agreement of time.(01 term)
- 19) Conditional tenders are liable to be rejected.
- 20) Contractor is solely responsible for safety of his all workers. In case of injuries sustained by his workers, Contractor is solely responsible to pay suitable amount of compensation till their recovery including cost of medical treatments/Hospitalization.



- 21) A reasonable completion time of each job will be mentioned separately in each work order issued from time to time on the basis of approved rates.
- 22) All debris and waste materials must be removed from the site and all trenches, road and passage must be repaired in original condition immediately on completion of the job.
- 23) The quoted rate for all areas should include contractors profit and all applicable taxes.
- 24) The contractor is bound to undertake job of his area, only in certain circumstances he cannot perform (Not more than 03 times), a penalty of PKR 50,000/- will be imposed.

SPECIAL CONDITIONS.

1. In Principle, one area will be awarded to one contractor. But, if a contractor is found lowest in more than one area and other contractors are not agreed to work on his quoted rates then he may be, awarded/asked to undertake the works of the other areas as well. In such case the contractor shall have to deposit the bid/security money of Rs. 15000/- for each additional area at the time of concluding the contract / contracts. The bid money will be confiscated if the contractor fails to undertake the other areas works (if required) as per his lowest bid.
2. While awarding the work of one area to a contractor who is found lowest in more than one area then his choice for any one area will be preferred. If management agrees.
3. PIA reserves the right to have 2/3 OR any number of standby contractors as per requirement of different areas in addition to the lowest contractors to have the T/C Works completed. This will be done when concerned manager is satisfied that area term contractor is not able to handle different scattered, abnormal or priority jobs of varying Scopes.
4. Area T.C Contractor will submit the bill/bills to concerned Manager within 10 days after completion of works, so that, quality and quantities of different items of works are readily checked in the newness of these executed items. Contractor will also make himself available in next 10 days to have this bill/bills checked by Works Officer. In case of delay on the part of contractors the decision of Works Division will be final and binding on Contractor.
5. Lowest quoted contractor rate in any area for each category, will be negotiated amongst others and will be implemented across the category, if incase the lowest /qualified bidder does not take the area, next standby contractor will be offered on same rate.
