1. **Chemical:**

- No artificial colour
- Fiber Crude - 2.5% to 2.7%.
- Protein - 16% to 18%

2. **Physical:**

- Freshly grained from fine wheat.
- Production made from cleaned wheat milling or grinding.
- Fresh and dry without any foreign objects / insect weevil.
- Proper sealed packing on delivery in 400 to 500 Gram Packet.
- Damaged, dirty and dusty packets are not acceptable.
- Reputable National brand (Local), ingredients and their nutritional information preferably given or mentioned.

3. **Sensory:**

- It shall not be bitter in taste, shall not smell bad.

4. **Labeling:**
